#### FROM THE BRIDGE:

Greetings Navy Leaguers,



In the American system of government, the highest position is citizen. A fundamental responsibility of a good citizen is to vote whenever eligible. With all the challenges of active duty service, unfortunately, the voting registration rate for active duty military (2018) was 12 percentage points lower than the general population when adjusting for demographic differences between service members and civilians (age, gender, education, etc.) These figures are provided by FVAB (Federal Voting Assistance Program) which is working hard to increase our active duty voting participation.

For Navy Leaguers here in Florida, we need to do better. Our County Supervisors of Elections (particularly in Flagler and St. Johns) provide abundant information to make voting convenient and safe.

If you are registered and ready to vote Flagler County information can be found at https://www.flaglerelections.com and St. Johns County information can be found at votesic.com. Familiarize yourself with the local, state, and federal candidates you are eligible to vote for. Remember, the 2000 presidential election came down to a difference of 537 votes in Florida. Some local elections in the last ten years have come down to single digit differences in the voting count.

#### MAKE YOUR VOTE COUNT!

Our Council, meeting by Zoom, has had a series of great speakers presenting to our members at our monthly meetings. In July, we had RADM Sinclair Harris (USN, Ret.), who gave a great presentation of a variety of issues facing our Navy (particularly personnel), and National defense (see the article on page 2). 

#### RADM Sinclair Harris:

On July 13th, the St. Augustine-Palm Coast Council hosted RADM Sinclair Harris USN ret. and currently NLUS Vice President, Maritime Policy as our guest speaker for the evening Membership meeting. Joining the St. Augustine-Palm Coast Council were members from the Mayport Council, as well as the Jacksonville Council, to hear Admiral Harris' remarks.





Sinc Harris is currently LMI's client relations executive for the defense sector. He retired as a rear admiral after a 34-year career in the U.S. Navy. His service culminated as the vice director for operations to chair of the Joint Chiefs of Staff. During his distinguished career, he led joint, combined, multinational, and interagency organizations both at sea and ashore across all aspects of defense, including full-spectrum operations, program management, strategic planning, and execution. He also commanded the U.S. Fourth Fleet, leading U.S. naval forces assigned to the U.S. Southern Command.

Sinc has been published in numerous journals on the topics of surface warfare, combat logistics, irregular warfare, and leadership. He earned a bachelor's in economics from James Madison University, a master's in operations research from the Naval Postgraduate School, and a master's in defense and strategic studies from the University of Madras, India. Sinc voluntarily serves as national vice president of the Navy League of the United States, chair of the National Defense Industrial Association's Expeditionary Warfare Division, president of the National Naval Officers Association, board member for the Surface Navy Association, and member of the Northern Virginia Armed Forces Communications and Electronics Association.

The Admiral's remarks concerning the current state of the USN, the effects COVID-19 is having on operational performance, future needs of the Navy and other matters of interest were well received by all in attendance. Admiral Harris also commented on the effects of the COVID-19 pandemic on NLUS and how it has altered operations at headquarters. As expected, the Admiral's presentation was both highly informative and highly engaging.

#### Alcohol, Drugs, and Peer Pressure: A Perfect Prescription for Addiction

About 21 million Americans have an addiction and are substance abusers. Did you know only 10% of addicts seek out and receive treatment? Did you know people between the ages of 18-25 are the biggest age group to develop addictive personalities? This coupled with the availability of drugs and alcohol and the social pressures to fit in, make teens an easy target for addiction. Teenagers nowadays constantly struggle with peer pressure. As a teenager, I feel these pressures on a daily basis. Teens are succumbing to the influences of their environments and are not allowing their inner confidence to guide their actions.

The cool thing now is vaping, even though teens have absolutely no idea what they are putting in their bodies. As a public high school student walking around the school, I witness other students trying to hide their vapes in their bags so they will not be caught by teachers and staff. Teens are often hiding in the restrooms or in the back of classrooms, trying to get their fix of nicotine... or whatever poison they are trying to put in their bodies. Teens have to think before lighting that cigarette, pouring that drink, or opening that pill bottle. Abusing alcohol and drugs takes a toll on mental and physical health. Mental health can plummet drastically, causing depression, anxiety, paranoia, and even psychosis. Drugs and alcohol can also impact physical health by causing seizures, heart attacks, strokes, and respiratory or cardiac failure.

In conclusion, teens must resist the peer pressure to do drugs and alcohol. They can lead teens down the lonely path of addiction, consuming their dreams, and possibly their life.

#### "What is the farthest you have ever traveled?"

A trip of 25,000 miles aboard the USS Midway CV-41 beginning three days before Christmas '54 at NAS Mayport, FL ending eight days after the Fourth of July '55 at NAS Alameda in San Francisco. There, our planes were off-loaded by crane, then commencing our ocean-to-ocean flight to Jacksonville. On East Coast arrival, our flight leader (of four planes) flew us from overhead Jacksonville's Cecil Field the additional 39 miles out to Mayport (and back) . . . just so that we could claim to have been all the way around the world . . . and . . . to 'show-off' by flying at (FAA approved) 1,500' along the St. Johns River over downtown . . . in a beautiful sunset . . . on a Friday-the-13th!



#### First Coast Honor Flight:



Council member Selena Hennandez-Haines, CDR USN(Ret) was the guest speaker at our August 10th (Zoom) membership meeting. She gave us the following presentation about her new organization, of which she is President, "First Coast Honor Flight".



**First Coast Honor Flight, Inc. (FCHF)**, a Florida 501(c)3 nonprofit corporation, is a new Hub in the nationwide Honor Flight Network and the first to serve Northeast Florida Veterans. Established in March 2020, FCHF will serve St. Johns, Flagler, Duval, Clay, Putnam, Nassau, Baker, and Bradford counties, an area which is home to more than 169,000 veterans.

Since 2005 the nationwide Honor Flight Network has transported more than 244,000 elderly and ill military Veterans to Washington D.C. at no cost to them, to visit the memorials and monuments commemorating their service and sacrifices. Priority is given, in order, to seriously ill Veterans of any service era, then to World War II, Korean War, and Vietnam War-era Veterans.

FCHF is excited about the opportunity to provide local Veterans with their "trip of a lifetime".

Our Honor Flights will depart from Jacksonville International Airport and be completed in one extraordinary day. Flights will include 25 Veterans, each accompanied by a trained Guardian. To ensure the safety and well-being of Veterans, Honor Flight groups include an M.D. and at least one EMT or RN, plus a handful of FCHF Staff to coordinate D.C.-area support and oversee trip execution.

FCHF is planning its inaugural Honor Flight for April 2021, on condition that it will be safe for Veterans and Guardians to travel then. The itinerary will include the World War II and Iwo Jima Memorials, the Korean and Vietnam War Memorials, front-row seats for the Changing of the Guard at the Tomb of the Unknowns at Arlington National Cemetery, and more.

We are actively seeking applications from Veterans and prospective Guardians who would like to travel with us in 2021! We also seek applications from Volunteers to help with 2021 events such as Flight Orientations, departures and returns at Jacksonville International Airport, and Flight Reunions. <u>To protect your personal information</u> we ask that completed applications be mailed to the address shown on the forms, rather than submitted by email.

**FCHF relies on generous donors' assistance to make Honor Flights possible for area Veterans.** We estimate one First Coast Honor Flight will run approximately \$25,000, from pre-flight Orientation through post-flight Reunion. Remember, Honor Flights are absolutely no-cost to Veterans! Donations are tax-deductible and can be made by check or by PayPal on our website.


